### **STATUTORY PAY FOR 2013**

The Statutory Minimum Pay was one of the subjects discussed in the Type 1 Sub-Committee on 25 October. However, the more pressing issue was the shortage of man-power. It had been a genuine headache for all operators, and caused the labour market to rise above the statutory minimum pay.

Also discussed in the meeting was the creation of a Q-Award for our guarding company members. This would provide a further deliberated effort to enhance top grade services in guarding. The Q-Award should provide our members an edge over the non member competitors. The Q-Concept should be taken forward by the Sub-Committee very shortly
